WHEREAS, The Mill Basin Deli is popular not just as a feast for the stomach but also for the eyes, thanks to paintings by world-renowned artists, such as Roy Lichtenstein and Marc Chagall, which Mark Schachner has hung on its walls over the years; and

WHEREAS, Though he has sold some works off the deli's walls, he now runs his art business through a nearby gallery, but continues to display beautiful artwork in the deli's dining room; and

WHEREAS, When he had the opportunity, Mark Schachner expanded the Avenue T deli into an adjacent storefront and he began making deliveries in the Pastrami Taxi when he bought a car through the Cash for Clunkers program and decorated with sandwich decals; and

WHEREAS, It is with great pleasure that this Legislative Body acknowl-

edges the success and acclaim of this exceptional restaurant and recognizes its many contributions to the Brooklyn community and economy; now, therefore, be it
