Pathfinder Award which recognizes individuals who have made longstanding contributions to the business officer profession; and

WHEREAS, Mary M. Lai helped build the foundation for the success of the National Association of College and University Business Officers; she was responsible for the advancement of the business officer profession in the United States; and

WHEREAS, Mary M. Lai earned a B.S. in Accounting from LIU's Brooklyn campus, graduating magna cum laude in 1942; and

WHEREAS, In 1941, Mary M. Lai married her college sweetheart, William T. "Buck" Lai, a graduate of the LIU Class of 1941; and

WHEREAS, This auspicious occasion presents a unique opportunity for this Legislative Body to recognize and pay tribute to Mary M. Lai; and WHEREAS, It is the sense of this Legislative Body that those who enhance the well-being and vitality of their profession and community, and have shown a long and sustained commitment to excellence, certainly have earned the recognition and applause of all citizens of this great Empire State; now, therefore, be it
