In January, over 70 high schools in NYC were designated as "Struggling" by the New York State Education Department. This forum will explore what is happening at high schools throughout New York City.



- Transfer schools and the impact of the Every Student Succeeds Act (ESSA) regulations
- Availability of guidance, college prep and college admissions counseling
- Availability of libraries, gyms and space for programming
- Advanced Placement Classes what courses are offered at each school
- Availability of student extracurricular activities and athletic programs

Dear Chancellor Carranza,

Specialized high schools in New York City are a great educational resource that provide our students with an unprecedented opportunity to excel in the public school system. Recently, there has been a renewed focus on the lack of diversity in these schools. Only 10% of students in these schools are Black or Latino even though they make up 70% of the overall student population.

I am supportive of efforts to increase access to the specialized schools and believe this is an opportune time for a comprehensive evaluation of all high schools citywide. In order to help broaden the discussion between the Legislature, the New York State Board of Regents and the New York City Department of Education with regard to policy and resources, I am requesting the following information for all public high schools:

- demographics of student population at each school
- admissions criteria
- per-pupil spending
- ratio of college counselors to students
- graduation rates and numbers
- college acceptance rate
- number of advanced placement courses offered and in what subjects
- status of science labs and school libraries
- academic programs offered at each school

While the conversation with regard to diversity in specialized high schools is a necessary one, the eight specialized high schools only serve a small fraction of students. All of our young people deserve the chance to meet their full potential.

As we consider a legislative remedy to the issue of diversity in the specialized high schools, it is my hope that we take this opportunity to evaluate the state of New York City's high schools overall. There are a number of high schools throughout the five boroughs that are high performing and successful yet are not part of the "specialized high school" system.

Your immediate attention to this request would be greatly appreciated. I look forward to our continued partnership on behalf of all students in the New York City public education system. Sincerely,
