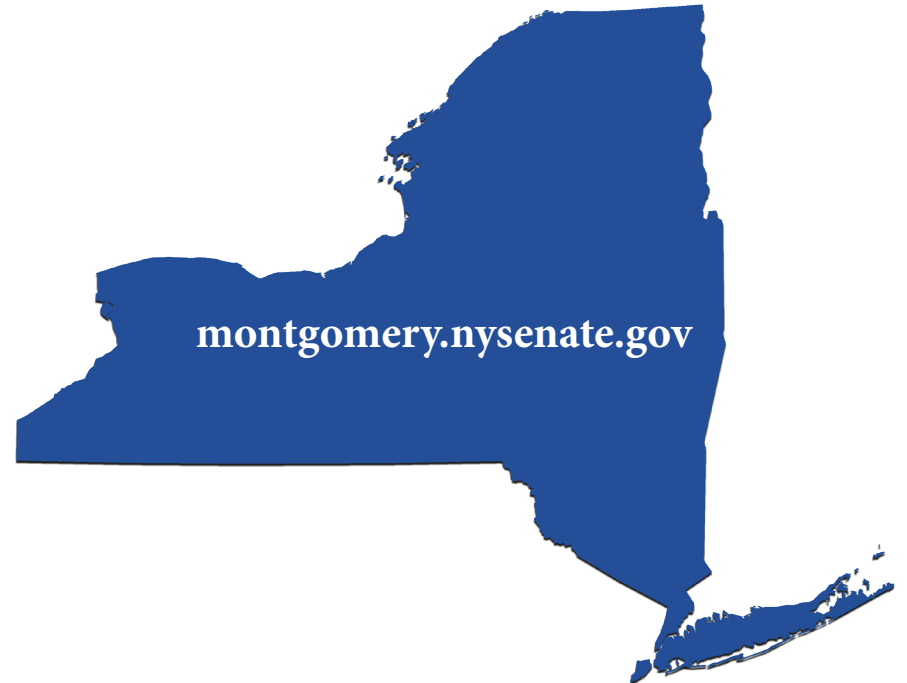

Dear Neighbor,

It is clear, more than ever, that every election matters and every vote counts. New Yorkers deserve the right to have their powerful voices heard and be given the ability to participate in the electoral process. **Under the leadership of Senate Democratic Majority Leader Andrea Stewart-Cousins and Assembly Speaker Carl Heastie, the Legislature passed historic election reforms to strengthen democracy in New York State.**

The reforms include:

- **Early Voting** to allow for primary and general elections to be open 10 days prior to Election Day.
- **Consolidation of State and Federal Primaries** into a single date to comply with the federal Military and Overseas Voter Empowerment (MOVE) Act.
- **Voter Registration Transfer** requires the Bd. of Elections to transfer the registration and enrollment of a voter to wherever they move in NYS.
- **Close the LLC Loophole.** LLCs will now have the same aggregate contribution limit of \$5,000 that applies to corporations; and increase transparency by requiring disclosure of the identity of individuals with membership interests in LLCs and attribute contributions to members of LLCs.
- **Pre-Registration of Eligible 16 –Year-Olds**, which would automatically make them registered voters by the time they reach the age of 18.
- **Extend Party Registration Deadline** to February 14th to allow more time for a voter to enroll in a party prior to a primary election.

Election Reforms Enacted through the FY 2019-2020 Budget:

- Authorized the usage of **electronic poll books** across the state.
- **All statewide primary poll sites will now be open from 6am to 9pm**, creating a more uniform process across the state.
- **\$10 million in funding to support the implementation of early voting.**
- Prohibits lobbyists, labor unions, PACs, and other independent expenditure committees from providing loans to candidates and committees.
- Establishes a temporary Public Campaign Financing and Election Commission to make **recommendations for the implementation of a voluntary public campaign financing system for statewide public offices.** The Commission has to report to the Legislature by December 1, 2019, said recommendation shall become law by December 22, 2019 unless overturned by the legislature.

I look forward to our continued partnership to increase voter empowerment.

EARLY VOTING FAQ

**For the first time in history,
New Yorkers have a choice:
Vote Early October 26 - November 3,
or Vote on Election Day, November 5.**

WHAT IS EARLY VOTING?

You can now vote in person during a nine-day period before the election, beginning Saturday October 26 and continuing through Sunday, November 3. This includes weekend and evening times to allow for voting flexibility.

DO I NEED A REASON TO VOTE EARLY?

No, you do not need a reason to vote early. Unlike absentee voting, you do not need to apply.

DO I NEED TO BE REGISTERED TO VOTE EARLY?

You must be registered in advance to vote in New York State, whether you vote early or on Election Day. For 2019, October 11 is the last day you can register to vote in person at your county Board of Elections office. Mailed voter registration forms must be postmarked by October 11. You can download a registration form on any New York Board of Elections website. You can also register online through the New York State DMV if you have a driver's license or non-driver ID.

WHERE DO I GO TO VOTE EARLY?

Your Early Voting Poll Site and your Election Day Poll Site may not be the same. Different counties have different early voting rules. Check VoteEarlyNY.org to find your Early Voting Poll Site.

IF MY COUNTY HAS MORE THAN ONE EARLY VOTING POLL SITE, CAN I GO TO ANY OF THEM?

It depends on your county. Check VoteEarlyNY.org to find out if you must vote at your assigned Early Voting Poll Site, or you can vote at any countywide voting center.

WHAT CAN I EXPECT AT MY POLL SITE?

The process for voting early on Election Day will be similar to how you have voted before, except many counties will be using electronic poll books (tablets) instead of paper registration books to check voters. Make sure that you sign your signature legibly using a stylus or pen when you check in, like you are signing a legal document. Your poll site may use iPads and ballot printers to modernize and make the process faster for voters.

WHEN WILL MY VOTE BE COUNTED IF I VOTE EARLY?

Early Voting ballots will be counted on Election Day, November 5.

CAN I CHANGE MY VOTE IF I VOTE EARLY?

No, you may only vote once per election.

WHAT IF I MOVED OR AM MOVING DURING THE EARLY VOTING PERIOD?

A new law passed in 2019 requires the Board of Elections to transfer a voter's registration automatically if the voter moves within the state and fills out a change of address form at USPS. As this is a new law, we strongly recommend that you update your registration with the Board of Elections. If your name is not in the poll book at your new address, you can vote on an affidavit ballot.

WHAT IF MY NAME IS NOT IN THE POLL BOOK?

Whether you vote early or on Election Day, there is a chance that your name may not be in the paper or electronic poll book. If that happens, make sure you are at the correct poll site for your address, and ask for an affidavit ballot to fill out. After Election Day, the Board of Elections will confirm your registration. If you are a qualified voter, your affidavit ballot will be counted. You might want to call your Board of Elections to confirm that it was.
