#### Racing, Gaming and Wagering Budget Items for State Fiscal Year 2015-2016

The Legislature adopted a budget of \$112 million for the Gaming Commission.

The Legislature denied the Executive proposal to reduce the VLT Impact aid of non-Yonkers municipalities from 70% of the 2008-09 level to 55% of 2008-09 level. This would have reduced aid to host municipalities by \$2.1 million

The Legislature appropriated \$100,000 in funding for the operations of the Racing Fan Advisory Council, which was not included in the original Executive proposal.

The Legislature modified the Executive proposal for a one year extension of the NYRA Reorganizational Board, from October 18, 2015 to October 18, 2016, by providing an immediate effective date for the extension.

The Legislature concurred with the Executive proposal for a one year extension of the deadline to receive approval for and to complete, capital projects through the Video Lottery Gaming vendor's capital award program.

The Legislature also concurred with the Executive proposal to include games of chance that contain a limited amount of skill within the definition of the term "video lottery gaming."

The Legislature concurred with the Executive proposal to extend the pari-mutuel tax rates for simulcasting out of state races for one year.

The Legislature added a provision to increase to 2% (from 1%) the amount of purse funds which are retained for the New York Jockey Injury Compensation Fund, Inc. until April 1, 2017.

The Legislature added a provision to extend the current vendor fee rates for a vendor track in Sullivan county for one year until April 1, 2016.

Finally, the Legislature added a provision to ensure off-track advanced deposit wagering (ADW) rate distribution parity for multi-jurisdictional providers who are part of joint affiliations or contractual agreements as of December 31, 2016.

#### Bills Reported by Racing, Gaming and Wagering Committee that were Enacted Into Law in 2015

#### Chapter 236 of the laws of 2015 – S.1866 Bonacic/ A.2132 Pretlow

This bill extends, for one year, the authorization for the New York State Thoroughbred Horsemen's Association to receive an additional 1.0% of purse monies collected from the race meetings at Aqueduct, Saratoga, and Belmont racetracks, until August 31, 2016.

#### Chapter 287 of the laws of 2015 – S.3424 Bonacic/ A.4925 Pretlow

This bill extends, for one year, the provisions of Chapter 473 of the laws of 2010 relating to the operations of the New York State Thoroughbred Breeding and Development Fund, until October 28, 2016. These provisions include: the requirement that payments to the fund be made on a quarterly basis; the authorization that sixty-five percent (65%) of revenue can be allotted to breeder awards; the authorization that six percent (6%) of revenue can be used for promoting the breeding and raising of thoroughbred horses; and the authorization that five percent (5%) of revenue can be used for administrative costs.

#### Chapter 300 of the laws of 2015 – S.4370 Marchione/ A.6332 Woerner

This bill allows Saratoga Harness Racing, Inc. to maintain its status as the "regional track" in the Capital Off-Track Betting Region.

#### Chapter 443 of the laws of 2015 – S.4934 Ranzenhofer/ A.6946 Pretlow

This bill removes the statutory prohibition on conducting horse racing and wagering on Palm Sunday.
