### **Overall Financial Plan Impact**

- All Funds spending for FY 2013 remains constant at \$132.6 billion.
- General Fund spending (including transfers) for FY 2013 is balanced at \$58.6 billion based on preliminary estimates subject to revision when the FY 2013 Enacted Budget Financial Plan is released in mid April. These amounts do not reflect the net effect of the FY 2012 close out.
- FY 2013 Legislative Budget reduces out year spending gaps from \$16.4 billion to \$7.4 billion.

#### **Department of Corrections and Community Supervision**

The Legislature concurs with the Executive recommendation of \$31 million.

#### <u>Part A – Expand the list of offenses for which DNA samples will be collected and entered into the</u> <u>State DNA Databank</u>

The Legislature amends the Executive proposal to change the effective date of the DNA expansion from October 1, 2012 to August 1, 2012, and to provide necessary resources to DCJS and State laboratories to process the additional samples, conduct profile comparisons and conduct DNA testing ordered by the courts.

#### <u>Part B – Repeal the requirement for a pistol and revolver ballistic identification database, known</u> as CoBIS and replace it with a nationally recognized alternative

The Legislature concurs with the Executive proposal to repeal the requirement for a pistol and revolver ballistic identification database, known as CoBIS and replace it with a nationally recognized alternative.

## <u>Part C – Require that the trial date for a traffic violation must be a date subsequent to the date of an initial appearance</u>

The Legislature concurs with the Executive proposal to require that the trial date for a traffic violation must be a date subsequent to the date of an initial appearance.

#### Part D – Provide more flexible probation sentencing options for the courts

The Legislature denies the Executive proposal related to persons sentenced to probation.

#### Part E – Expand the forfeiture of proceeds

The Legislature denies the Executive proposal to expand the authority of State judges to order the forfeiture of proceeds in a sentencing.

#### <u>Part F – Continue provisions relating to the disposition of certain monies recovered by county</u> <u>district attorneys</u>

The Legislature accepts the Executive proposal to continue to allow District Attorneys in New York City (City) to retain a portion of settlement recoveries they make before the filing of an accusatory instrument against a defendant. This provision is provided for one year.

#### <u>Part G – Clarifies Municipalities Responsibilities When They Receive or Offer Aid Through</u> <u>Intrastate Mutual Aid Program (IMAP)</u>

The Legislature amends the Executive proposal to clarify municipalities responsibilities when they receive or offer aid through Intrastate Mutual Aid Program (IMAP). Technical amendments are made including allowing the Commissioner to develop a plan or process allowing the inclusion of school districts' and Board of Cooperative Educational Services' participation in the Intrastate Mutual Aid Program.

#### <u>Part H – Establish a Tier VI retirement benefit for new employees of the State and local</u> <u>governments</u>

Intentionally Omitted. (Prior enactment outside of the budget process).

#### <u>Part I – Expand 2010 Medicare Part B reform to include employees and retirees of public</u> <u>authorities</u>

The Legislature accepts the Executive proposal to require employees and retirees of public authorities to share in the cost of Medicare Part B premiums in the same manner as active and retired state employees.

#### Part J – Lapse Aged State and Local Reappropriations

The Legislature denies the Executive proposal to automatically lapse state and local reappropriations older than 5 years.

#### Part K – Modify the schedule of payments in lieu of taxes (PILOTs) made to the City of Albany

The Legislature concurs with the Executive proposal authorizing an increase in the 2012-2013 South Mall Pilot payment of \$7.85 million to the City of Albany. The 2032-2033 Pilot payment for the City of Albany is decreased respectively by the same amount. This provision is included in Part K of the Education, Labor, and Family Assistance Article VII bill.

#### Part L – Modify outdated Statewide procurement procedures and printing practices

The Legislature amends the Executive proposal related to centralized procurement as follows:

- Denies proposal to purchase commodities using "best value" and to purchase services using lowest price.
- Accepts modification of the definition of "best value to permit agencies to add a quantitative factor for small businesses or certified minority- or women-owned business to be used in the evaluation of best value bids.
- Expands the use of State centralized contracts by allowing additional piggybacking rights to local governments, non-profit organizations and other authorized users.
- Amends several sections of the State Finance Law to increase centralized contracting, including establishing that centralized service are accorded second priority, and authorizing the Commissioner of Office of General Services (OGS), in his or her discretion, or at the request of an agency, to use a centralized contract to procure services.
- Exempts centralized contracts let by OGS from the Office of the State Comptroller pre-audit prior to contract finalization.
- Expands the Commissioner's investigatory authority to acquire information from a state agency under the control of the Governor information he or she deems necessary to exercise his or her powers and duties related to the purchasing of services and commodities.
- Authorizes three-year pilot program to permit agencies to require electronic bidding, including the use of reverse auctions, for commodity and service contracts provided the agency first makes a determination that vendors will not be adversely impacted by use of electronic bidding.
- Increases from \$15,000 to \$50,000 the dollar amount of procurement at and above which public notice is required.
- Expands the definition of a commodity in the Education Law and State Finance Law to include electronic information resources.
- Enacts public disclosure requirements for sole source contracts.

#### <u>Part M – Make various reforms to the Civil Service Law to provide increased flexibility with</u> respect to hiring and transferring State Employees

The Legislature denies the Executive proposal to reenact provisions of law related to term appointments and allowing increased flexibility in the hiring and promotion of state employees.

#### <u>Part N – Authorize transfers, temporary loans, repeal of the Community Projects Fund and</u> <u>amendments to miscellaneous capital/debt provisions, including bond caps</u>

Intentionally Omitted from this bill and included in S.6259

#### Part O – Rename the Office for Technology as the Office of Information Technology Services

The Legislature concurs with the Executive proposal to rename the Office For Technology the "Office Of Information Technology Services."

#### Part P – Accelerate Aid and Incentives for municipalities funding for the City of Rochester

The Legislature amends and accepts the Executive proposal and includes the proposal in Part S of the Education, Labor, and Family Assistance Article VII bill. This provision authorizes advanced AIM payments for the following cities:

- City of Amsterdam -- \$2,100,000
- City of Aubur -- \$3,400,000
- City of Buffalo -- \$30,000,000
- City of Corning -- \$900,000
- City of Lackawana -- \$3,600,000
- City of Long Beach -- \$1,400,000

- City of Rochester -- \$28,000,000
- City of Syracuse -- \$30,000,000

These advanced AIM payments would be authorized upon written request and only in amounts necessary to close a budget gap for the ensuing 2012-13 city fiscal year. This provision is included in Part S of the Education, Labor, and Family Assistance Article VII bill.

#### <u>Part Q – Pay the MTA for costs associated with promoting access to employment through</u> reimbursements for E-ZPass tolls paid by residents of Broad Channel and the Rockaway Peninsula that travel over the Cross Bay Veterans Memorial Bridge

The Legislature concurs with the Executive's proposal to provide an MTA E-ZPass toll rebate program relating to the Cross Bay Veterans Memorial Bridge.

## <u>Part R – Delays Implementation of Assessment of Fee for Worker's Compensation Group Self-Insured Fund</u>

The Legislature amends the Executive's Proposal to delay the implementation of an assessment on self-insurers and group self-insured trusts to 2015 instead of the proposed 2016.

#### Part S – Leg. Law sec. 5-A

Provides language for the annual extension of Legislative Law §5-a.

#### <u>Part T – Facility Parole</u>

Provides language that would provide employees previously in the facility parole officer title to be transferred to an open parole officer or senior parole officer position before that position is filled by a newly hired employee.

#### Part U – Department of Corrections and Community Supervision (DOCCS) Study

The Legislature amends current reporting requirements for the Department of Corrections and Community Supervision by requiring information on the total number of correctional facilities in operation which are maintained by the department, the security level of each facility, the number of beds at each facility as of December thirty-first of the prior year, as classified by the department, and the number of empty beds, if any, by such classification as of such date. In addition, the information would be posted on the Department's website annually by February 1<sup>st</sup>.

#### Part V - Cyberbullying Chapter Amendment

The Legislature amends cyberbullying language to provide clarification for diversion programs which were created in the original bill for youth involved in cyberbullying and/or sexting conduct.

#### Part W – NYSDA/DA's Sunset

The Legislature provides language to amend the Indigent Legal Services Fund to make backup center support for public defense services an allowable purpose and provides language for the State to reimburse counties for the statutory increase to District Attorney salaries mandated by the Judicial salary increase. Both of these provisions are effective for only one year.

- The Legislature authorizes an increase of \$805 million in new school aid spending by using \$400 million to further reduce the Gap Elimination Adjustment reprogramming \$111 million through Foundation Aid, increasing \$230 million in expense based aids, \$50 million in competitive grants, and \$3 million in miscellaneous categorical programs.
- The Legislature concurs with the Executive's proposal to require districts participating in the Contract for Excellence program to continue operating approved academic intervention programs consistent with Contract for excellence requirements. The required investment in these programs would be permitted to decline by the same percentage as the districts formula based aid reduction under the Gap Elimination Adjustment. This approach would ensure the continued participation of 23 school districts, including all "Big Five" city school districts (New York City, Buffalo, Rochester, Syracuse and Yonkers).
- The Legislature authorizes requirement of the Office of Temporary and Disability Assistance to work in conjunction with the State Education Department to make data available to school districts of students available for the Free and Reduced Price Lunch (FRPL) Program. Eligibility will result in automatic enrollment in FRPL.
- The Legislature authorizes the State Education Department to fund districts who incorrectly filed data with the State Education Department for Universal Prekindergarten, providing the correction of data submission.
- The Legislature concurs with the Executive to extend the date of awarding competitive performance grants to one hundred and twenty days after the 2011-12 school year. This will allow bonus points to be considered for early submission and approval of an Annual Teacher Performance Review.
- The Legislature authorizes \$125 million in competitive grants for the 2013-14 school year. A \$50 million portion will be included in school aid as in 2012-13. The remaining \$75 million will be funded through prior year appropriations.
- The Legislature authorizes shifting responsibility of payment for students attending Schools for the Blind and Deaf from the district of admission to the district of residence in the 2013-14 school year.
- The Legislature authorizes requirement of New York City to transport students attending grades Kindergarten through Six who attend public and nonpublic schools after five pm.
- The Legislature concurs with the Executive's proposal to allow districts that failed to file final cost report data with the State education Department to only be penalized for the length of time the report was delinquent.
- The Legislature authorizes the State Education Department to validate transportation contracts beginning in the 2004-05 school year which were denied as a result of inadvertent or clerical errors, upon approval of the Commissioner of Education.
- The Legislature authorizes the Commissioner of Education to provide transition aid to districts with Annual Professional Performance reviews when the submitted plan does not meet the required standards as set forth by the Commissioner and the cost of developing a new plan would be greater than that of the original.
- The Legislature denies the Executive's proposal to require school districts to purchase buses and bus equipment from the state contract.

#### Part A-1 - Annual Teacher Performance Reviews -- Intentionally Omitted

#### Part A-2 - Annual Teacher Performance Review-NYC Appeal Process -- Intentionally Omitted

#### <u>Part B – Teacher Hearings</u>

- The Legislature denies the Executive's proposal to shift the cost of teacher hearings to the employee or employee bargaining unit.
- The Legislature modifies the Executive's proposal to reform teacher hearings, authorizing the Commissioner of Education to appoint an arbitrator if neither party to the hearing has done so after fifteen days.
- The State Education Department will also be able to set maximum rates for the payment of arbitrators and limit allowable study hours.
- SED is authorized to monitor and investigate hearing officer compliance with the statutory guidelines any deficiencies in the commencement or completion of hearings within the statutory time periods will result in the hearing officer no longer being on the eligible list of arbitrators.
- SED is authorized to use new technology to transcribe or record 3020-A hearings.
- All evidence shall be submitted by all parties within 125 days of filing charges with exceptions made for extraordinary circumstances.

#### Part C – Authorize the Pass-Through of the 2013 Federal SSI Cost of Living Adjustment

The Legislature concurs with the Executive proposal to implement a Social Security Income (SSI) Cost of Living Adjustment (COLA) beginning January 1, 2013.

#### Part D – Phase in the Scheduled Public Assistance Grant Increase

The Legislature amends the Executive proposal that would phase-in the final 10% increase to the public assistance grant. Instead, the Legislature provides for a 5% increase on July 1, 2012 and the remaining 5% increase on October 1, 2012 to achieve full implementation of the final 10 percent public assistance grant increase in this fiscal year.

#### Part E – Authorize State Administration of the State Supplemental Security Income

The Legislature concurs with the Executive proposal that would authorize the State to administer the State Supplementation Program for SSI recipients.

#### Part F – Reauthorize Child Welfare Financing provisions

The Legislature amends the Executive's proposal to extend the current reimbursement structure for child welfare financing for an additional five years as follows:

- Denies the proposal to reduce State reimbursement for Child Welfare Services in statute from 65 percent to 62 percent;
- Denies the proposal to add Subsidized Kinship Guardianship Assistance in statute as an allowable expense of the Foster Care Block Grant;
- Denies the proposal to reduce State reimbursement for Adoption Subsidies in statute from 65 percent; and
- Continues to notwithstand statute in appropriation language, for the above changes, to reflect current reimbursement practice.

#### Part G – Enact Juvenile Justice Reform

The Legislature amends the Executive proposed "Close to Home Initiative" to include the following:

- Require additional public hearings to examine the plan for NYC to operate limited-secure facilities;
- Prohibit approval of a plan to operate limited-secure facilities prior to April 1, 2013;
- Require notice of any transfers be provided to the attorney for the respondent and the parent;
- Retain judicial authority to order specific services upon placing a youth in NYC, and the authority to order specific placements in voluntary agencies outside of NYC;
- Retain judicial authority to order minimum placements of up to six months for youth placed in non-secure facilities who have committed a felony offense;
- Limit the time period under which a youth may be placed in a local detention facility pending his or her court proceeding;
- Require consultation of independent experts in the validation of the risk assessment instrument as well any disparate impact on certain populations; and,
- Require specific criteria be considered in determining the closure of facilities, and sunset such authorization to close facilities upon sixty days notice on April 1, 2014.

#### <u> Part H – HECap Extender</u>

The Legislature accepts the Executive proposal to extend the Higher Education Capital Matching Grant Program through March 31, 2013.

#### <u>Part I – Cornell University MOU</u>

The Legislature amends the Executive proposal to provide for the development of a Master Agreement with general terms and conditions and the use of Memoranda of Understanding between state agencies and Cornell University, to facilitate the provision of services and technical assistance to the State.

#### Part J – Pre-school Special Education

- The Legislature denies the Executive's proposal to shift a portion of growth in Preschool Special Education Costs from counties to school districts and the State.
- The Legislature denies the Executive's proposal to require an arms-length relationship between evaluators and providers of Special Education Preschool services.
- The Legislature denies the Executive's proposal to require evaluators to take proximity into consideration when placing student.

#### Part K – Authorizes OCFS to enter into contracts with BOCES

The Legislature amends the Executive's proposal to allow OCFS to contract with BOCES to provide services in juvenile justice facilities. Changes include specifying that such contracts may only provide for special educations services, and requiring a report detailing the cost effectiveness and programmatic impact of such contracts.

#### Part L – Annual Report on the Youth Center Facility Program

The Legislature accepts the Executive's proposal to repeal the requirement that OCFS issue an annual report on the Youth Center Facility program. This report was associated with Youth Opportunity Centers, which no longer exist and have not received State funding since 1994.

#### Part M – Sharing of Information Between OCFS and Local Probation Departments

The Legislature amends the Executive's proposal to allow sharing of information related to the detention risk assessment instrument. Changes include enhancing confidentiality of such information, and requiring consultation with experts on the effectiveness of the instrument any disparate impact on certain populations.

#### Part N – Remediation Study

The Legislature includes provisions to direct the State University of New York and the City University of New York to conduct a joint study regarding the issue of student remediation by November 1, 2012

#### Part O – NY-SUNY 2020 Challenge Grant Program Definition

The Legislature agrees to define the new SUNY 2020 Challenge Grant Program as long-term economic and academic plans submitted by non-university centers, which would be subject to the approval of the Governor and Chancellor.

#### Part P – NY-SUNY 2020 Non-resident Undergraduate Tuition

The Legislature agrees to a technical amendment to NY-SUNY 2020 (Chapter 260 of the Laws of 2011) to allow the tuition rates for non-resident undergraduate students at University Centers to increase. The rate increase will become effective beginning with the semester following the approval of the University Center's master plan.

#### Part Q – Charge back Study

The Legislature agrees to direct the State University of New York and the City University of New York to conduct a joint study examining the laws, regulations, and policies regarding community college charges for non-resident students and chargeback fees by September 1, 2012.

#### Part R - Red Light Cameras in Nassau and Suffolk Counties

The Legislature provides the authority for Nassau and Suffolk Counties to increase the number of red light cameras from 50 to 100 for each of their counties. There is no authority to increase fees or surcharges.

#### Part S - Aid Incentives to Municipalities

The Legislature amends the Executive proposal to authorize advanced AIM payments up to the respective amounts for the following cities:

City of Amsterdam -- \$1,667,846 City of Auburn -- \$2,689,127 City of Buffalo -- \$11,746,781 City of Corning -- \$678,774 City of Lackawanna --\$2,616,181 City of Long Beach -- \$952,955 City of Olean - \$1,900,000 City of Rensselaer -- \$218,663 City of Rochester -- \$15,187,454 City of Syracuse - \$20,885,777 City of Watertown -- \$2,419,172 City of White Plains -- \$1,292,569 City of Yonkers -- \$1,438,537 These advanced AIM payments would be authorized upon written request to the Director of the Budget and only in the amounts necessary to close a budget gap for the ensuing 2012-13 City Fiscal Year. This Part was proposed as Part P of the Public Protection and General Government Article VII budget bill.

#### Part T - Albany Pilot Payment

This provision was originally proposed as Part K of the Public Protection General Government bill authorizing an increase in the 2012-2013 South Mall Pilot payment to the City of Albany of \$7.85 M. The 2032-2033 Pilot payment for Albany is decreased by the same amount.

#### Part U – Tax Increment Financing

The Legislature authorizes the pledge of increased school property taxes under the tax increment financing program for bonds issued for municipal redevelopment.

#### Part V – Limited English Proficiency

Provides that the commissioner of education, in conjunction with the commissioner of health, shall promulgate regulations requiring mail order pharmacies, and pharmacies belonging to a chain consisting of ten or more locations in the state, to provide oral interpretation and written translation. Further, these provisions provide pharmacies with immunity from liability for injuries caused by third-party contractors, and requires the establishment of a waiver process through which pharmacies may seek exemptions if provisions prove unnecessarily burdensome.

#### Part W – State Veterans' Cemetery

The Legislature agrees to authorize the Division of Veterans' Affairs to pursue a federal grant for the construction of a state veterans cemetery and to contract with the County of Putnam to maintain such cemetery.

# SFY 2012-13 Health and Mental Hygiene Article VII S.6256-D / A.9056-D

#### Health and Mental Hygiene Article VII Budget Bill S.2809-D /A.4009-D

#### Part A: Enacts Early Intervention Reform

The Legislature modifies the Executive proposal to enact Early Intervention reforms by rejecting all proposed insurance network requirements for providers and insurers, and by rejecting all "arms-length" relationship provisions.

#### Part B: Roswell Park Cancer Institute (RPCI)

The Legislature modifies the Executive proposal to require the Roswell Park Cancer Institute to become financially and operationally independent in 2014. The Legislature requires RPCI to develop a plan by January 1, 2014 that specifies how the Institute will promote the health of patients, conduct innovative research, secure financial viability, and achieve operational and fiscal independence, however does not require effectuation of the plan by a certain date.

#### Part C: Establish System to Electronically Report Deaths

The Legislature denies the Executive proposal to require a contribution from funeral directors and undertakers to establish a system to electronically report deaths to the Department of Health.

#### Part D: Enact Medicaid Redesign Phase II Recommendations

The Legislature modifies the Executive proposal as follows:

- Require the Commissioner to allocate Supportive Housing funds based on efficiency and effectiveness of funding, and requires a report on the distribution of funds;
- Allow Assisted Living Programs (ALPs) to contract with more than one long-term home health care program, certified home health agency and/or other qualified provider and by clarifying the reimbursement of ALPs for pre-admission assessments;
- Repeal the social service law requiring establishment of ALP beds following the decertification of an equal or greater number of nursing home beds. The amendment allows the ALP program to continue to expand the number of beds without the requirement that a nursing home bed must be eliminated in order for an ALP bed to become available;
- Expand enteral formula therapy further to include individuals with other diseases and conditions;
- Modifies the Executive proposal to allow HIV special needs plans to enroll related children up to age 21 and other high needs populations, as determined by the Commissioner, by requiring the Department to clarify who "other high needs populations" are, and to clarify a methodology for reimbursement;
- Deny the proposal to require 120-days notice to the public health and health planning council if a not-for-profit hospital corporation wants to make a change in the board of directors;
- Deny the proposal to authorize the Commissioner to temporarily appoint members of the board, and to suspend or limit an operating certificate of a not-for-profit corporation without a hearing under certain conditions;
- Deny the proposal to require that board members subject to indictment or action for removal shall immediately and completely cease and withdraw from participation in the management, governance or operation of the hospital;
- Deny the proposal to authorize the Commissioner to appoint a temporary operator of a facility in the event of severe management failures that endanger the life, health or safety of residents or patients;

- Extend the authority of the Dormitory Authority of the State of New York to establish one or more subsidiaries to reduce potential liability by limiting the extension to Article 28 regulated entities only;
- Deny the proposal to eliminate the requirements of DOH to post certain information on their website related to meetings of the Pharmacy and Therapeutic Committee;
- Deny the proposal to extend funding under the Health Care Efficiency and Affordability Law for New York (HEAL-NY) to Diagnostic and Treatment Centers;
- Modify the proposal to extend the Commissioner's authority to issue regulations limiting reimbursement for potentially preventable conditions and complications to the outpatient setting by mirroring existing Medicaid provisions;
- Deny the proposal to require counties that have implemented a mandatory managed care program to use the Statewide enrollment broker;
- Deny the proposal to eliminate the requirement for applicants that operate managed long term care plans be a hospital, certified or licensed home care agency, health maintenance organization or not-for-profit organization with a history of providing or coordinating health care and long-term care services to the elderly and disabled persons;
- Deny the proposal to prohibit a spouse or parent from refusing to contribute any available income or assets towards the cost of health care services being provided to a spouse or family member; and
- Modify the proposal to authorize the Commissioner to promulgate rules and regulations to award the Empire Clinical Research Investigation Program (ECRIP) by adding clarification language.

The Legislature advances new legislation to:

- Establish a workgroup on Medicaid reimbursement for medically fragile children;
- Stipulate that Health care Efficiency and Affordability Law of New Yorkers (HEAL NY) funds be distributed equitably across health planning regions;
- Require managed care providers to cover medically necessary prescription drugs in the atypical antipsychotic therapeutic class;
- Require DOH to consult with stakeholders about effectively extending Managed Long Term Care to the nursing home population in a manner that reasonably addresses concerns regarding capital financing and its impact on payment rates;
- Repeal the expanded definition of estates under Medicaid;
- Establish a rural home tele-health delivery demonstration;
- Require DOH to develop transition and continuity of care policies for participants in home and community based long term care, including the Long Term Home Health Care Program, as they move into managed long term care plans;
- Authorize DOH to issue an expedited Certificate of Need (CON) review for existing Long Term Home Health Plans applying to become Certified Home Health Agencies by authorizing the commissioner to waive certain elements of the review;
- Establish a prescription pain medication awareness program to educate the public and health care practitioners about the risks associated with prescribing and taking controlled substance pain medication;
- Streamline the application process for distribution of the funds from the Doctor's Across New York program;
- Establish a process for limited or administrative review for any eligible capital projects under Federally Qualified Health Centers;

- Direct the Commissioner of Health to develop regulations regarding facilitating and regulating the use of a triage system of care and require the commissioner to submit a report to the Legislature in one year;
- Codify the Enhancing the Quality of Adult Living (EQUAL) program;
- Limit the use of specialty drug lists that require consumers to use mail order for certain prescriptions to those defined as specialty drugs by the Commissioner of Health; and
- Require the Office of the Medicaid Inspector General to publish on its website all final decisions and determinations resulting from the appeal of an action by the Office.

#### Part E: Establish a Health Care Benefit Exchange

The Legislature denies the Executive proposal to establish a Health Care Benefit Exchange in New York State.

#### Part F: Medicaid Local Takeover and Medicaid Administration Takeover

- The Legislature concurs with the Executive proposal to phase in the takeover of the growth of local Medicaid Expenditures.
- The Legislature modifies the Executive proposal to take over the local administration of the Medicaid program as follows:
  - Require the Department of Health (DOH), within 120 days of the effective date of this part, to develop and implement a Local Social Services District (LDSS) Statement of Interest to solicit their interests and capacities to contract with DOH;
  - Require DOH to submit an annual progress report to the Legislature beginning December 31, 2012 until the final implementation of the takeover; and
  - Establish a redistribution pool that would redistribute funds to LDSSs that exceed, or are projected to exceed, the administrative cap. DOH will be required to proportionally allocate any aggregate Medicaid administrative savings to counties that exceed their Medicaid administrative expenditures cap.

#### Part G: Medicaid Extenders

The Legislature concurs with the Executive proposal to extend certain Medicaid provisions.

#### <u>Part H – Human Services Cost of Living Adjustment (COLA); Annual Adjustments to</u> <u>Established Provider Payments; and Caps on Administrative Reimbursement and Executive</u> <u>Compensation</u>

The Legislature denies the Executive's proposal to repeal the Human Services COLA, and instead extends the suspension for one additional year. The Legislature denies the Executive's proposals to create a new system for provider adjustments, and to establish caps on executive compensation and administrative costs.

#### <u> Part I – 1115 Waiver Pilot Programs</u>

The Legislature denies the Executive's proposal to allow the Commissioner of the Office for People with Developmental Disabilities (OPWDD) to enter into contracts for the purposes of the People First 1115 Waiver Demonstration Program without a competitive bid process.

#### Part J – Office for People with Developmental Disabilities Organizational Restructuring

The Legislature modifies the Executive's proposal, retaining statutory language regarding existing developmental disabilities services centers and the Institute for Basic Research. Pursuant to this proposal, the Commissioner may administratively restructure OPWDD, but would be required to report to the Legislature 60 days prior to any significant service reductions.

#### Part K – Comprehensive Psychiatric Emergency Program

The Legislature concurs with the Executive's proposal to extend this program for four years.

#### <u>Park L – Streamlining Regulatory Requirements for Office within the Department of Mental</u> <u>Hygiene and Department of Health</u>

The Legislature modifies the Executive's recommendation to allow the Commissioners of the Office of Mental Health (OMH), the Office of Alcoholism and Substance Abuse Services (OASAS), the Office for People with Developmental Disabilities (OPWDD), and the Department of Health (DOH) to establish joint operating, reporting and construction requirements by including provisions prohibiting the circumvention of statutory requirements, and by requiring that such actions increase efficiencies and reduce administrative burdens.

#### Part M – Education for Children in Mental Health Facilities

The Legislature modifies the Executive's proposal to create pilot programs intended to improve the quality of education received by children in residential facilities by clarifying that that the participation of local school districts and Boards of Cooperative Educational Services (BOCES) can participate at their option as well as being held financially harmless.

#### Part N - Creation of the Behavioral Health Services Council

The Legislature modifies the Executive's proposal to replace the Mental Health Services Council and the Advisory Council on Alcoholism and Substance Abuse Services with a new Behavioral Health Services Council to ensure the continuation of current representation on the council, as well as continuing current reporting requirements to the Legislature.

#### Part O –Office of Mental Health Facilities

The Legislature modifies the Executive's proposal by raising the notification requirements for significant service reductions from 30 to 45 days in the event of closure of wards or the conversion of beds to transitional placement programs, and raising the notification requirements to 75 days from 60 days in the event of closure, merger or consolidation of facilities. Further, bed reductions are capped at 400 for the SFY — a decrease of 33 percent from SFY 2011-12.

#### Part P – Sex Offender Management and Treatment Act (SOMTA)

The Legislature concurs with the Executive's proposal to provide that defendants awaiting adjudication of a civil commitment proceeding, who have been referred to a treatment program and are significantly disruptive of such program, may be sanctioned by a return to DOCCS for a period of six months. The Legislature also agreed to allow psychiatrist examiners who are called as witnesses at a civil commitment proceeding to testify via electronic appearance. The Legislature also agreed to provisions clarifying that annual reports regarding the status of the defendant shall be due one year from the last determination or waiver of examination, whichever is later. The Legislature denies the Executive proposal to allow for the privatization of the care, treatment and security services for the SOMTA population.

#### Part Q - Options for 730 Defendants

The Legislature concurs with the Executive's proposal to broaden the definition of appropriate institution to allow hospitals with OMH-licensed psychiatric units to provide restorative care to defendants who have been deemed incapacitated. The Legislature also concurs, in certain circumstances and with approval by the District Attorney, allowing such defendants to receive outpatient restorative care; provided that such care shall be limited to a period of 90 days, and granted only with a continuation of any orders regarding bail. The Legislature denies the Executive proposal allowing local jails to provide restorative care.

#### Part R – Exempt Income Recoveries

The Legislature concurs with the Executive's recommendation to continue the fiscal periods for which the OMH is authorized to recover exempt income for community residences and family based treatment programs.

#### Part S: Excess Medical Malpractice Coverage Pool

The Legislature modifies the Executive proposal as follows:

- Limit access to the pool to physicians or dentists who had a full or partial policy for coverage period ending June 30, 2010, June 30, 2011, and June 30, 2012;
- Authorize hospitals to certify physicians and dentists on a proportional basis if the number of physicians or dentists eligible under this methodology is less than the number of physicians or dentists who had coverage on June 30, 2010; and
- Require the Superintendent of the Department of Financial Services and the Commissioner of Health to review and issue a report to the Legislature by November 1, 2012 on the coverage pool.

#### Part T: Elderly Pharmaceutical Insurance Coverage (EPIC)

The Legislature advances legislation that restores the fee and deductible plan for co-payment assistance under EPIC. Under the new plan, prescriptions will continue to be paid by Medicare Part D, but EPIC will pay the Medicare Part D co-payment. Co-payments for seniors in EPIC will range from \$3 and \$20.

SFY 2012-13 Transportation Economic Development and Environmental Conservation Article VII S.6258-D / A.9058-D

#### Part A – Marchiselli and CHIPS Annual Authorization

The Legislature concurs with the Executive proposal to provide \$39.7 million in Marchiselli funding and \$363.1 million for the CHIPs program. The Legislature also includes a provision to authorize the use of CHIPs funds on specified pavement resurfacing work types. A one year authorization for this type of work was given in the SFY 2011-12 Enacted Budget.

#### <u>Part B – Consolidation of the Accident Damage Recovery Account into the Dedicated Highway</u> <u>and Bridge Trust Fund (DHBTF)</u>

The Legislature concurs with the Executive proposal to consolidate the Accident Damage Recovery account into the Dedicated Highway and Bridge Trust Fund (DHBTF) and transfer all Funds for the repair of damaged infrastructure. These payments will now be made out of the DHBTF.

#### Part C – Bus Inspections

The Legislature modifies the Executive proposal to require the DOT to perform bus inspections every six months and authorizes the Department to establish an additional risk-based inspection program.

#### Part D – Commercial Motor Vehicle Federal Compliance

The Legislature modifies the Executive proposal relating to commercial vehicle operators to ensure the continued receipt of \$36 million in federal highway aid this year.

#### Part E – Metropolitan Transportation Authority

The Legislature modifies the Executive proposal of a \$7 billion increase to the MTA's bond limit ceiling by providing the increase evenly over three years. This would increase the bond limit to \$41.88 billion by 2014.

#### Part F – County Clerks Retention Rate for DMV Services Online

The Legislature concurs with the Executive proposal to establish additional retention rates, based on internet transactions for County Clerks acting as an agent of the Department of Motor Vehicles.

#### Part G – Federal Motor Carrier Compliance

The Legislature modifies the Executive proposal to amend provisions of law relating to safety, hours of service and hazardous material transportation requirements for commercial motor vehicles and carriers. These modifications include preserving the State exemption for farm vehicles, utility service vehicles and tow trucks, in order to ensure the continued receipt of \$4 million in federal grants.

#### Part H – Eliminate tagging requirements and streamline fish and wildlife licenses and permits.

The Legislature amends the Executive proposal that authorizes the classification of muskrats, the elimination of certain tagging requirements for carcasses and the extension of licenses and permit periods. The Legislature denies the proposal to re-impose the ten cent per bushel quahog and surf-clam fee that expired on April 1, 2010.

#### Part I – VOIP Deregulation

The Legislature denies the Executive's attempt to reaffirm in statute that there is no intent by the Executive to impose additional regulatory burdens on the expansion of broadband and the utilization of voice over internet protocol technology in underserved areas of New York State.

#### Part J - Exemption of hazardous waste and wastewater fees for recycled materials

The Legislature concurs with the Executive proposal to exempt producers of hazardous wastes and wastewaters from the fees and surcharges currently imposed on the production of these by-products, if these by-products are recycled and introduced back into the fabrication stream as part of the manufacturing process.

#### Part K-Terminates State operating support of the Environmental Facilities Corporation (EFC)

The Legislature concurs with the Executive's proposal to eliminate State Operating Fund support for the Environmental Facilities Corporation (EFC), effectively taking EFC "off-budget".

## <u>Part L – Eliminate the mandate that the New York State Agricultural Experiment Station be the exclusive seed testing entity in the State, and allow testing to be conducted by the Department of Agriculture and Markets or a qualified laboratory</u>

The Legislature concurs with the Executive proposal that would eliminate the requirement that the New York State Agricultural Experiment Station at Cornell be the exclusive seed testing laboratory in New York.

#### Part M – Out-of-State Cost Recovery.

The Legislature amends the Executive proposal to authorize the Department of Agriculture and Markets to enter into agreements with governmental and educational entities and be reimbursed for its services by limiting the scope to contracts with out-of-state entities.

#### Part N – Food Account Shifts.

The Legislature concurs with the Executive proposal to eliminate special revenue funds that support the Consumer Food and the Commercial Feed Licensing Account, shifting these appropriations to the General Fund.

#### <u>Part O – Transfer \$913,000 from New York State Energy Research and Development Authority to</u> <u>the General Fund</u>

The Legislature concurs with the Executive's proposal to transfer \$913,000 from the Unrestricted Corporate Funds of the Authority to the General Fund in order to offset New York State's debt service requirements related to the Western New York Nuclear Service Center. This authorization is provided annually.

#### <u>Part P - Finance the New York State Energy Research and Development Authority and the</u> <u>Department of Environmental Conservation's climate change program with assessments on gas</u> <u>and electric corporations</u>

The Legislature accepts the Executive's proposal to finance a portion of the Authority's research, development and demonstration, and policy and planning programs, and to finance the Department of Environmental Conservation's Climate Change Program, through an annual assessment on gas and electric corporations.

#### Part Q – Sale of Property of the Jacob Javits Convention Center

The Legislature denies the Executive proposal to deposit the proceeds from the sale of any property of the New York Convention Center Corporation (Javits) to the General Fund.

#### Part R – UDC Loan Authorization

The Legislature amends the Executive proposal to provide permanent authorization for the Empire State Development Corporation, and instead authorizes the provision for one year.

#### Part S – Empire State Economic Development Fund

The Legislature amends the Executive proposal to extend the Economic Development Fund for one year.

#### Part T – UDC Grant Making Authority

The Legislature denies the Executive proposal to provide ESDC with general grant making powers

#### Part U – Expansion of Linked Deposit Program

The Legislature concurs with the Executive proposal to expand the Linked Deposit program to agribusinesses.

#### <u>Part V -. Authorize the Department of Health to finance certain activities with revenues generated</u> from an assessment on cable television companies

The Legislature concurs with the Executive's proposal to make the Department of Health's public service education expenses eligible for funding from the Department of Public Service's assessment on cable television companies.

<u>**Part W -. Extends the renewal period for certain disciplines licensed by the Department of State</u> Intentionally omitted.</u>** 

#### Part X: Escheatment of Un-cashed Vouchers

The Legislature denies the Executive proposal to make un-cashed pari-mutuel vouchers subject to escheatment to the Regulation of Racing Account. This is part is intentionally omitted from the Executive's TED Article VII bill.

#### Part Y: Transfer Racing and Wagering Employees to Harness Tracks

The Legislature modifies the Executive proposal to transfer the responsibility of providing one starter and one judge from the Racing and Wagering Board to each licensed Harness Track by requiring each licensed harness track to reimburse the Racing and Wagering Board for the cost associated with providing one starter and one judge at each licensed harness track.

#### Part Z - Dairy Market Order.

The Legislature denies the Executive proposal to authorize dairy market orders to fund activities for assisting dairy farmers through an assessment on milk production.

#### Part AA – Cost Recovery Assessment

The Legislature amends the Executive proposal to increase the cap on cost recovery assessments on public authorities from \$60 million to \$62 million, increasing the cap to \$65 million.

#### Part BB – Provision of Construction Services by the Dormitory Authority

The Legislature amends the Executive proposal to authorize the Dormitory Authority to provide construction services and financing to all state agencies and public corporations and instead authorizes the Dormitory Authority to provide construction services only to the Office of Parks, Recreation, and Historic Preservation and the Department of Environmental Conservation.

#### Part CC – Categorize Not-for–Profits and Service of Process Requirements.

Intentionally Omitted

#### <u>Part DD – Amend the Green Jobs-Green New York on-bill program to allow the recording of a</u> <u>declaration rather than a mortgage</u>

The Legislature concurs with the Executive's proposal to require that, for Green Jobs-Green New York loans that are to be repaid through an on-bill recovery mechanism, NYSERDA must record a declaration with the local recording officer indicating the existence of such loan, and to remove the current requirement that NYSERDA record a non-enforceable mortgage for on-bill recovery financing.

#### <u>Part EE – Extends period of compliance for retrofitting heavy-duty diesel vehicles pursuant to the</u> <u>Diesel Emissions Reduction Act</u>

Extends the start date of compliance for retrofitting heavy-duty diesel vehicles owned by State agencies or public authorities, as well as contractors who work on public job sites, with best available retrofit technology pursuant to the Diesel Emissions Reduction Act (DERA) of 2006 from December 31, 2012 to December 31, 2013.

#### Part FF – Gift Cards for hunting and fishing licenses

Authorizes the Commissioner of the Department of Environmental Conservation to establish procedures for the sale and redemption of gift cards for procuring required licenses and related stamps for fishing and hunting activities in New York State.

#### Part GG – Establishes the Western New York Power Proceeds Allocation Act

Authorizes the funding of an expanded array of economic development activities from unallocated reserved hydropower dedicated to and reserved for the Niagara / Erie Corridor to stimulate Western New York's economic and employment opportunities.

#### Part HH – New York Works Task Force

This provision authorizes the establishment of the New York Works Task Force for the purpose of coordinating the capital plans of New York State Agencies and authorities.

#### <u>Part II: Advanced Deposit Wagering Study, OTB Bankruptcy and Capital Acquisition Fund</u> <u>Relief</u>

The Legislature authorizes all municipal OTBs to enter into bankruptcy if the Racing and Wagering Board determines a municipal OTB is financially insolvent and the county or majority of participating counties with a municipal OTB region provides a resolution authorizing the municipal OTB to enter into bankruptcy.

The Legislature authorizes municipal OTBs to use their capital acquisition funds for general operating purposes if the fund balance is \$2.5 million or less. A municipal OTB that chooses to use its capital acquisition funds for general operating purposes will have the one percent surcharge on bets used to fund capital acquisition, suspended for either one year after the fund is depleted or the OTB notifies the Racing and Wagering that it is no longer using those funds for general operating purposes. This part also mandates the board conduct a study on out of state advanced deposit wagering and report its recommendations to the Governor and Legislature by September 15, 2012

#### Part A – Oil and Gas Unit Production Values Fee Extender

The Legislature concurs with the Executive proposal to extend for three years until March 31, 2015, fees for the establishment of oil and gas unit of production values for purposes of calculating real property tax assessments.

#### Part B - STAR Tax Offset for Unpaid Liabilities

The Legislature amends the Executive proposal to allow the Commissioner of the Department of Taxation and Finance to develop a STAR benefit Recovery Program which seeks to suspend a taxpayers basic or enhanced STAR exemption if the taxpayer owed any past due state tax liability over \$4,500. The amount of the STAR benefit suspension will be used to reduce the taxpayer's liability. The liability must be fixed and final with no ability left for administrative or judicial review of such liability. The Tax Department must notify the taxpayer at least 45 days prior to the school year for which the STAR suspension will apply. This provision will only be in affect for the 2013-2014 through 2015-2016 school years.

#### Part C – Tobacco Products Excise Tax Changes – Intentionally Omitted

#### Part D – Alternative Fuels Exemption Extension

The Legislature amends the Executive proposal to extend the alternative fuels tax exemptions for two years. Extends the sunset date of the exemption for alternative fuels from September 1, 2012 to September 1, 2014, to allow E85, compressed natural gas, and hydrogen a full exemption and B20 a partial exemption from the motor fuel tax, the petroleum business tax, the fuel use tax, and state and local sales taxes. Expected to save taxpayers \$1.6 M in 2012-13 and \$3.2 M for 2013-14.

#### Part E – Diesel Motor Fuel Amendment

The Legislature concurs with the Executive proposal to make technical amendments to the tax classification of diesel motor fuel. Addresses unintended consequences of the amendments to the motor fuel definitions enacted as part of the SFY 2011-12 Enacted Budget, to give an upfront exemption for Crude Oil and Biodiesel where no liability was intended to be triggered.

#### Part F - Refusal of Sales Tax Certificates of Authority- Intentionally Omitted

#### Part G – Extend Tax Modernization Provisions

The Legislature amends the Executive's proposal to extend for one year, until December 31, 2013, the Tax Modernization provisions enacted in the SFY 2011-12 Enacted Budget as follows:

- Amends the efile mandate on tax preparers to raise the threshold for mandatory efiling to the federal standard of more than 10 returns in the prior year; clarifies the language so that if a return contains a form that does not have the ability to be efiled then the entire return will not have to be efiled; and clarifies that the threshold of number of returns is counted per taxpayer, and not per form.
- Extends the requirement for e-filing and e-pay for all personal income taxpayers who use tax software to prepare their return but removes the \$25 penalty.
- Extends the Department of Tax and Finance's authorization to require sales tax vendors that have been delinquent in payments, to set up a segregated bank account in which the taxpayer will be required to make weekly deposits of sales tax collections. The Department would then sweep these accounts after the deposit.

### <u>Part H – Solar Installations Sales Tax Exemption and Solar Energy Systems Lease Credit</u> – Intentionally Omitted

#### Part I – Commercial Production Credit

The Legislature amends the Executive proposal to extend the Empire State Commercial Production Tax Credit for three years. Also amends the credit structure to more equitably disperse the regional pools, but allows the statewide pool to absorb unallocated credits for redistribution.

#### Part J – Low-Income Housing Credit

The Legislature amends the Executive proposal to authorize an additional \$8 million in low-income housing credits for the current fiscal year and an additional \$8 million next year. The credits can be claimed for a ten year period. This would allow the Commissioner of Housing and Community Renewal to allocate an annual total of \$48 million in credits in 2013.

#### Part K – Bio-Fuel Production Credit

The Legislature concurs with the Executive proposal to extend the bio-fuel production credit that is scheduled to expire at the end of 2012. The credit of 15 cents per gallon produced would be extended until the end of 2019. The maximum any facility could earn is capped at \$2.5 million annually. This proposal will provide \$10 million in benefits beginning in SFY 2014-15.

#### Part L – Enhanced Earned Income Tax Credit for Non-Custodial Parents

The Legislature amends the Executive proposal to extend the enhanced Earned Income Tax Credit for two years. This credit was authorized in 2006 as an incentive for non-custodial parents to be responsible for the economic well being of their children. However, this tax credit is due to sunset on December 31, 2012. The tax credit is equal to the greater of twenty percent of the Federal EITC for a taxpayer with one child or 2.5 times the Federal EITC for a taxpayer with no children. In order to qualify for this credit, the non-custodial parent must be older than 18 and current on his child support payments. This proposal would decrease revenues by \$4 million beginning in SFY 2014-15.

#### Part M – Prohibiting Bank Fees on Tax Levy Transfers – Intentionally Omitted

#### <u>Part N – Payroll Mobility Tax Payments by Professional Employer Organizations</u>

The Legislature concurs with the Executive proposal to include professional employer organizations as employers subject to the lower payroll mobility tax rates. Professional employer organizations are companies that provide services to small businesses (e.g. payroll services). These services reduce the cost of doing business for the small business. The payroll tax would be calculated separately upon the payroll expense of the organization itself and the payroll expenses of each of its member businesses. Currently, these organizations must calculate the tax on the aggregate amount of all the payroll expenses of their member businesses. This proposal would have no fiscal impact.

#### Part O – Pari-Mutuel Tax

The Legislature concurs with the Executive proposal extending lower pari-mutuel tax rates and rules governing simulcasting of out-of-state races for one year.

#### Part P – Utility Tax Allocation for Transportation

The Legislature amends the Executive proposal to include an expiration date of March 31, 2013 related to sub-allocating the current 80 percent of Section 183 and 184 receipts that are deposited into the Mass Transportation Operating Assistance Fund (MTOA) so that 26 percent of these receipts would be deposited into the Public Transportation Systems Operating Assistance Account (PTOA) and 54 percent would be deposited in the MTOA Account. The remaining 20 percent of receipts would continue to be deposited in the Dedicated Highway and Bridge Trust Fund. At present, only receipts from the Petroleum Business Tax are allocated to the PTOA Account. PTOA has had an annual shortfall requiring a recurring transfer from the MTOA account. The sub-allocation is estimated to be worth \$21.45 million in SFY 2012-13.

#### Part Q – Hotel Room Remarketers Amendments

The Legislature concurs with the Executive proposal to facilitate the compliance of room remarketers with the duty to collect sales tax and New York City hotel room occupancy tax on hotel occupancies. Adds new subdivision (r) to section 1111 of the Tax Law and the accompanying reference change, which would provide the following relief to room remarketers:

- With regard to transactions in which a customer obtains occupancy together with other items, for one price, provides room remarketers with a way of computing the portion of the bill taxable as rent; the room remarketers may compute such amount based on the consideration payable to the hotel for the occupancy relative to the consideration payable for the other items, or may use any other method authorized by the commissioner
- Would permit room remarketers to not specify the amount of the sales tax due on occupancy at the time the customer makes the reservation and instead to provide the information on any invoice given to the customer prior to the completion of the occupancy.
- Room remarketers would report occupancy transactions in the sales tax filing period in which the occupancy ended, rather than in the sales tax period during which they collected the consideration for the occupancy.
- Amends Tax Law section 1119(e) to relieve a room remarketer of the burden of obtaining the certificate of authority number of the hotel that sold the occupancy in order to qualify for a credit or refund of the sales tax the room remarketer paid to the hotel for the occupancy.
- Allows room remarketers to supply certain identifying information about the hotel, including its address and telephone number, instead of the certificate of authority number when the hotel refuses to supply the latter number.
- Amends the New York City Administrative Code to make some similar changes to provisions regarding room remarketers' obligation to collect the City's hotel room occupancy tax and to change some internal cross-references to other sections of the Administrative Code.

#### Part R – Gramm-Leech-Bliley Extender

The Legislature adds a two year extension of the Gramm-Leech-Bliley provisions and adds a technical fix to allow a corporation that is taxed as a bank due to the extension of the Gramm-Leach-Bliley transitional provisions to make a one-time designation to correct the unintended negative consequences.

#### <u>Part S – Quick Draw</u>

The Legislature adds provisions to eliminate the Quick Draw food percentage restrictions. Establishments holding an alcohol beverage license for on premise consumption, whose sales from food make up less than 25 percent of gross sales will now be able to operate the game of quick draw on their premise.

#### Part T – Youth Jobs Tax Credit Extension

The Legislature adds an extension to the end of the period for application to the Youth Jobs Tax Credit program from June 1 to November 1, 2012 and an extension of the hiring period end from July 1 to December 31, 2012.

#### Part U – Administration of Certain Funds and Accounts and Debt Management Provisions

The Legislature amends various transfers to and from the General Fund and amends bond caps in relation to the authorization of bond issuances for capital programs of the State.

SFY 2012-13 Merger of State Entities Article VII S.6260-C / A.9060-C

#### <u>Part A – Merger of the Division of Lottery and the Racing and Wagering Board into the Newly</u> <u>Created New York State Gaming Commission</u>

The Legislature modifies the Executive's Article VII Legislation to merge the Division of Lottery and the Racing and Wagering Board into a newly created Gaming Commission. The Commission will be governed by a seven member board, five appointed by the Governor, one member appointed by the Senate Majority Leader and one by the Speaker of the Assembly. The Governor will pick the chairman of the board and appoint an executive director to run the day to day operations of the commission. The seven board members and the executive director will be subject to Senate confirmation. The Executive Director will oversee four divisions including The Lottery, Charitable Gaming, Gaming; and Horse Racing and Pari-Mutuel Wagering Division. Lottery revenues will continue to fund education. The merger will take place on October 1, 2012.

#### Part B – Merge the Department of Civil Service and the Governor's Office of Employee Relations

The Legislature denies the Executive's proposal to merge the Department of Civil Service and the Governor's Office of Employee Relations.

#### <u>Part C – Transfers Belleavre Mountain Ski Center from the Department of Environmental</u> <u>Conservation to the New York State Olympic Regional Development Authority</u>

The Legislature amends the Executive's proposal to transfer the operation, maintenance, and management of the Belleayre Mountain Ski Center (Belleayre), from the Department of Environmental Conservation (DEC) to the Olympic Regional Development Authority (ORDA) by providing greater local representation on the ORDA board through two new seats dedicated to residents of Ulster and Delaware County. This Part ensures that all current full time and part time employees shall be transferred and retain their respective civil service classifications, status, salary, wages and negotiating unit for their total length of employment at Belleayre.

#### Part D – Merges Various Boards and Commissions

The Legislature amends the Executive's proposal to eliminate or repeal various Councils, Boards, Commissions, and Committees, and denies the Executive's proposal to eliminate the following entities:

- The Minority and Women-Owned Business Enterprise (MWBE) Advisory Board
- The Temporary Advisory Committee on the Restoration and Display of New York State's Military Battle Flags
- The Manufactured Housing Advisory Council
- The Child Performer Advisory Board to Prevent Eating Disorders

The Legislature denies the Executive's proposal to merge several Emergency Medical Services (EMS) Councils into one State Advisory Board.
