

Testimony by Tamara Keshecki & Jen Lyon The New York Independent Venue Association before the Joint Legislative Public Hearing on the FY2023 Executive Budget Proposal: Economic Development

On behalf of the New York Independent Venue Association (NYIVA), thank you for the opportunity to provide testimony on the proposed FY2023 Executive Budget. NYIVA represents over 200 live performance venues, festivals, and promoters including comedy clubs, jazz clubs, performing arts centers, historic theaters, and spaces both for-profit and nonprofit throughout the State of New York. Our members are nonprofit organizations, independently owned, and operated businesses, not publicly traded or multi-national corporations.

Our members act as the training grounds for up and comers before they play in the world's largest spotlights, and are also the pinnacle of the spotlights themselves. We are the open mic nights where Lady Gaga honed her craft, the stages where Jerry Seinfeld worked up his first "tight ten," and the spaces where the only limits to artistic innovation are the ceiling heights. We create the artistic havens that become drivers of economic growth and are the cornerstones keeping local main streets alive and vibrant. We ask your help to revive a cherished industry that has been all but decimated by the COVID-19 pandemic.

Our industry has been uniquely and seriously harmed by the COVID-19 pandemic and we ask with urgency for the State to recapitalize and modify the programs established last year. Since reopening began in June 2021 after a 15-month long state-mandated closure, NYIVA members reported a decline of over 50% in ticket sales in comparison with 2019 as per a November 2021 survey conducted before the emergence of the Omicron variant. During the state-mandated closure, members incurred a collective net loss of \$15 million per month. Additionally, as Governor Hochul noted, our industry has been one of the slowest to return with employment still at a 20% decline as of November 2021.

We thank the legislature for your intent last year to help our sector with relief funds, but sadly we must report that due to tight eligibility criteria, most of our members were unable to gain access to that support. Revenue caps, participation in federal relief programs, or having to be a recent agency grantee, created roadblocks to application, none of which were indicators of whether state support was needed. Unlike relief funds in other states, NYS chose to separate our sector by tax status, for-profit and nonprofit, placing for-profit arts with other businesses and disqualifying nonprofits from accessing the robust \$800M small business fund. The differing eligibility requirements of each program's design resulted in a lack of parity amongst similar for-profit businesses and nonprofit organizations creating an uneven policy playing field that selected winners and losers.

Both programs assumed that receipt of a limited amount of federal relief dollars was a sufficient response for the scope of the pandemic-created need and chose that as a disqualifier for state-based relief. However, considering that NYS experienced the longest state mandated closure in the country, that limitation prevented many at-need venues from receiving much needed state support. Additionally, receipt of federal relief was not an eligibility disqualifier for other state-created relief funds.

NYS suffered some of the deepest human tolls during the pandemic, and it is understandable that our sector was shut down in the interest of public health. With over 30 other states and localities having created arts and venue-specific funds, with some of the most recent including \$150 million in California, \$17 million in venue specific relief in New Jersey, and Michigan recently voting to provide a second round of relief funding to venues, we implore that NYS value our sector's economic contributions as deeply as our counterparts.

We respectfully ask that you:

- Create a \$150 million, three-year stabilization fund, open to both for-profit and nonprofit live performing arts venues and promoters.
- Remove receipt of federal relief dollars as a barrier to eligibility for existing and forthcoming grant opportunities. Federal support alone is not sufficient to address the scope of the state mandated closure, and ongoing decrease in ticket sales, attendance, and cancellations due to COVID.
- Open the Small Business Relief fund to nonprofit performing arts organizations.
- Raise the maximum grant award amount to \$250,000 to be on par with other state relief programs such as CA and NJ.
- Allow previous recipients to reapply for a higher amount.
- Remove the revenue cap restriction. Live performing arts have high gross revenues but low net profits due to the nature of the business.
- Support the Governor's proposal to permanently legalize to-go drinks.

Thank you for your time and consideration of our sector and its needs. With your support, the NYS arts and culture sector will not only revive the soul of NYS, it will rev its economic engine roaring back to life.
