## Dear Comptroller DiNapoli:

We write to you today to call your attention to the costs associated with the state's planned subsidies for the building and operation of wind farms off of Long Island. In particular, I am alarmed by the disparate projections and a general lack of transparency surrounding massive projected costs to taxpayers. For these reasons, we would ask you to conduct an audit of the bid and accurately assess the costs to New York taxpayers.

The New York State Energy Research and Development Agency (NYSERDA) said in a recent filing that the subsidy awarded had "values" totaling \$2.2 billion. However, an analysis by the non-partisan Empire Center for Public Policy puts the inflation-adjusted subsidies--the actual cost to ratepayers--at more than \$6 billion.

A reported difference of that magnitude causes concern for ratepayers and for us as elected officials and stewards of government. The fact that New York ratepayers will bear these costs without a firm financial estimate is especially alarming. Considering these inconsistent financial projections by state policymakers and agencies, we believe it is imperative that your office help determine an accurate assessment of the costs to taxpayers through an independent fiscal audit.

Your office has the objectivity and expertise to help determine the figures behind the subsidies as well as their long-term cost to New Yorkers. We hope that you will help us provide the necessary transparency to the millions of New Yorkers who will be dramatically impacted by this policy.
