## Good evening

Thank you all for taking the time to come here to our small town. I appreciate your commute today. It's usually myself driving to Albany to work. I really didn't know what to expect today. I've never attended a Senate hearing before. I've sat and listened now for hours. We've heard from multiple professionals from multiple agencies and capacities and other victims. One thing missing seems to be from a personal level. We heard from Mr. Michaels regarding health effects. I would like to share the impact of myself, a lifelong resident of the Town of Hoosick, and the effect of PFOA on myself and my family.

I was born in Bennington in 1967. I lived with my parents on Barton Avenue for the first 9 years of my life. My father was born and raised here and I like him love my community and chose to stay here to raise my family.

1967 - Born in Bennington, VT

Lived with my parents on Barton Avenue due east of St. Gobain

Village Water

1976 - Family moved to North Hoosick Road due east of landfill

Village water

1980 - Family cat - facial tumor

1992 - Married - moved to Troy

1995 - Returned to Hoosick Falls with my newborn son

Nursed son for 9 months

1998 - Our cat "Oliver" became ill

Took my son's pet to Dr. Genelis in Bennington to get better

Our cat was poisoned – source unknown

Our house cat never went outside

He had complete liver and kidney failure

I had to have him euthanized that day

My vet wanted to perform an autopsy

I couldn't afford that

Instead he had the cat food analyzed – no poison

I never thought it could be our water

2000 – Became pregnant with second child

I was diagnosed with high risk pregnancy

My daughter was diagnosed with chromosomal abnormality (possibly down syndrome, spina bifida, deafness/blind)

My husband and I were told not to spend the next 6 months of our pregnancy worrying

This was the longest 6 months of my life

Daughter was born, rushed off, cleared healthy

2001 – I found a lump in my throat at my daughters 6 week check up

I was referred to Albany Med for second opinion

I had a needle biopsy – thyroid checked and clear

2002 - I had been hospitalized with kidney stones

2003 – I was diagnosed with hyperparathyroidism

Could result in high calcium levels

Could cause stroke

2007 – Daughter diagnosed with autoimmune disease at age 6 – precocious puberty

2008 - Son became ill

Son diagnosed with autoimmune disease – diabetes type 1

Dozens of hospitalizations since

I was diagnosed with uterine fibroids

Resulted in anemia

2009 - Diagnosed with breast cancer

2 surgeries resulted

2010 – Osteoarthritis right foot surgery

Surgery on parathyroid and right side of thyroid nodules enlarged

Second thyroid surgery to remove remainder

2011 - Confirmed autoimmune disease - celiac disease

Multiple tests, scans, biopsies, appointments, blood work, medicine

Complete hysterectomy

April '11 Stowe, VT – cancer survivor symposium

Took my kids

Attended thyroid summer group

Heard Tony Sena from Tony Sena with genzyme

He spoke of odds of having thyroid cancer

Odds one in 3,000 (+/-)

I raised my hand and asked what were the odds of 8 persons in one high school class

He referred me to the CDC

I wrote to them and they responded

They stated it "wasn't uncommon for cancer clusters" in a community and local agencies would monitor

Dec. '14 Dog was ill and had multiple tumors on her body

We rented a home in the village from Nov. 2012 through Nov. 2014. Today was the first I've heard of a letter being sent by the village regarding the water. Our then land lord never provided us with a letter or notice of any water concerns. We purchased our home north of the village June 2014 and moved in Nov. 2014.

March '16 Family tested

Children's levels higher than mine

They are 21 and 15

My husband's level is the highest

He worked in 4 of the plants in town

He relocated out of NYS for 25 years.

I want to thank you all for staying today. I've been standing in the shadows throughout all of this. I've spoke with local politicians, many emails, phone calls, texts. We all hope these hearings are productive. We all hope that our children are cared for and are able to have medical monitoring. I'm almost 50 and I need to know my children will be cared for and hoping that what has taken place here in Hoosick Falls can be an example – a poster child have you, for what NOT to do in the future. I would like to think that our legacy will be how passionately we

defended and fought for our children and their children. I was talking to a woman at Cumberland farms this morning and I asked her if she was coming today. She said no. They can't do anything she said. I told her how sick my family is. She asked how do I prove it? I've got blood tests. How can you prove it's not? This has been a very humbling experience and my family is closer now. Thank you.
